4.1) **MONTROSE COUNTY COMMUNITY PARTNERSHIP AGREEMENT**

Interim Town Administrator, Patty Gabriel, told the Board this agreement is for the \$50,000 grant from Montrose County in which the Board allocated to the General Fund with \$40,000 for the Police Department and \$10,000 to the Community Center in the 2023 Town budget.

A motion by Trustee Christine Kinion authorizing the Mayor's signature on the 2023 Montrose County Community Partnership agreement was seconded by Mayor Pro Tem Greg Davidson. Discussion – None.
