REGULAR MEETING

Ms. Garrett told the Board that an Alpine Bank representative had reached out to discuss the option of closing the existing Alpine Bank CD earning below 1% interest and moving those funds to a Money Market Savings account which will earn 5% interest.

A motion by Trustee Christine Kinion approving the closing of the Alpine Bank CD and opening a Money Market Savings account with Alpine Bank was seconded by Mayor Pro Tem Greg Davidson. Discussion- None. The motion passed with a six to zero vote in favor.
